## TERMS & CONDITIONS

1. Membership is a commitment for a minimum of 12 months, whether paying by monthly standing order or annual in advance.
2. a) Payments by instalment are due regardless of club usage. In the event of a payment default, entry in all competitions will be suspended.  
  
b) In addition the member is forthwith liable for the full amount due, notwithstanding that the Company has agreed to permit them to pay the amount due in instalments. The Member accordingly agrees that if they fail to make payment of any one instalment by the due date then the full outstanding amount:
  - i) Shall become due and payable immediately unless the default is remedied by the following payment; and/or
  - ii) Shall accrue interest at the premium rate charged by the Company's Bankers from time to time unless the default is remedied by the following payment.  
c) Should the Company be obliged to institute legal proceedings against the Member arising from breach of the terms of this Membership Agreement, including but in no way limited to their failure to pay any amount due by the due date, the Member acknowledges that they should be liable for all tracing fees, collection commission and legal costs as may be allowed by the Court.
3. The Company is not responsible for the loss of personal items or damage to personal property, either on the premises or in the parking area unless caused by the neglect of the Company or its staff. Membership insurance is included in the annual subscription. Please see the Club Secretary if you need to make a claim.
4. When using a guest pass, guests must be accompanied by the Member. Guest passes are not valid after the expiry date.
